Travel Documents

U.S. Citizens must be in possession of a valid passport with not less than six months validity remaining. Non U.S. Citizens should consult the appropriate consulates.

Deposits & Payments

A non-refundable deposit of \$1,000 per person for the "Highlights of Sweden and Norway" Tour is due now, and should be submitted with the completed and signed reservation form to confirm your booking.

One half of remainder of tour cost is due April 1, 2011.

The trip balance is due no later than May 14, 2011.

Rates & Fares

All rates and fares are those in effect as of January 1, 2011. Prices are based on guaranteed, advanced bookings with each supplier (i.e. hotels); seasonal and occupancy variations may occur. Ingebretsen's, Ted & Diane Noble are not responsible for any such price variances. This tour represents a package price and an itemization of individual component cost will not be rendered. The right is reserved to substitute hotel property and location when necessary due to availability, from those described in the itinerary. Clients will be responsible for any charges required due to voluntary itinerary deviations at the request of the traveler.

Changes & Cancellations

Full refund, less 20% of the tour cost per person handling charge, will be made if cancellation is received in writing no later than April 15, 2011. Cancellation notice received after April 15, 2011 will be assessed the following fees: April 16-May 25, 2011: 55% of tour cost per person: After May 25, 2011 no refund of the tour cost. No refund for any part of tour you do not utilize or voluntarily change; if you cancel while tour is in progress, there will be no refund of the tour cost for unused portions.
